**1. TRIP/EVENT SIGN-UP AND PAYMENT**

- B. Everyone participating in SCC Community Ski Club trips must be accompanied by their **Parent, Legal Guardian, or have permission from their parent/guardian to travel with another SCC family.**
- C. Registration for all club trips or events must include this registration form and the ticket cost. Tickets shall be purchased by cash or by check made payable to **SCC** (memo – ski club).
- D. If rentals are needed please note on form and contact Mrs. Barnes for prices.
- E. Students are expected to follow the school rules as presented in the school handbook for field trips. Please refer to page 9 and 10 of the Student Parent School Handbook.
- F. **As this is a school trip, alcohol consumption is NOT allowed by any participant.**

**2. CANCELLATIONS**

- A. Cancellation with full refund will be made if done **before the last day of sign-up**. Trip prices are based on 20 or more skiers, so we cannot refund money after the trip is booked (last day of sign-up/payment due date).
- B. We will refund money if the trip is cancelled due to lack of participants or if weather conditions are deemed dangerous for travel.

Also, I accept the continuing responsibility to acquaint myself with the hazards and risks inherent in any ski/snowboarding activity and trip, and I agree not to participate in any activity unless I fully understand all risks attendant thereto. I agree that this waiver shall continue in full legal force and effect until the day I notify the SCC Community Ski Club in writing that I no longer agree to the provisions of this waiver, and this notice is acknowledged by SCC Community Ski Club and SCC School.”
